Figures are specification minima. Reported values carry a standard analytical uncertainty of ±2%. Total THC is derived: Δ9-THC + (THCA × 0.877). Coating and infusion grade are the same molecule to different specifications — infusion retains its minor cannabinoids deliberately, which is what gives it colour and a broader profile.
